

# CO-FOUNDER BIOGRAPHIES

## Bipul Sinha / Co-founder and CEO

Bipul has over 18 years of experience in building billion-dollar products and companies from the ground up. Previously, he was a partner at Lightspeed, where he invested in Nutanix, PernixData (acq by Nutanix), and Numerify. Before that, Bipul worked at Blumberg Capital where he was the founding investor and board member of Nutanix, a “multi-billion dollar unicorn” company that has revolutionized the enterprise data storage industry. Previously, Bipul was Director of Database Products at Oracle Corporation, where he led development of core data and transaction processing technologies. Bipul also held sales and engineering positions at American Megatrends and IBM.

Bipul received a Bachelor of Technology (Honors) in Electrical Engineering from Indian Institute of Technology, Kharagpur and an MBA from The Wharton School where he was a Palmer Scholar. Bipul also holds several patents in distributed computing.

## Arvind Nithrakashyap / Co-founder and CTO

Arvind has over 16 years of experience building storage, databases and distributed systems. Arvind led the real-time ad infrastructure team at Rocketfuel where he built the core real-time ad platform to handle 50 billion requests per day. Previously, he worked at Purisma (acquired by Dun & Bradstreet) in the Customer Data Integration space, where he helped scale the product to hundreds of millions of customer records. He started his career at Oracle where he worked as a Principal Engineer in the areas of Caching, Recovery and Real Application Clusters. While at Oracle, he co-founded Exadata storage platform, which is now the primary storage platform for Oracle Database and fastest growing business in Oracle’s 40-year history, generating \$3 billion a year.

Arvind received a Bachelor of Technology in Computer Science from Indian Institute of Technology, Madras and a Master of Science in Computer Science from the University of Massachusetts, Amherst.

## Arvind Jain / Co-founder and VP of Engineering

Arvind was a Distinguished Engineer at Google where he spent over 10 years in various engineering and management roles. He managed Internet access initiatives at Google, where he started and managed the Google Fiber program. As founder and Managing Director of Google India, he started and managed Mapmaker, a product that helped Google build online maps for the entire world solely from crowdsourced data. While at Google, he founded and currently chairs the World Wide Web Consortium’s Performance Group. Prior to Google, he was the first engineer at Riverbed, where he built the original engineering team and was responsible for the overall technical architecture of the product. Before that, he helped start the video division at Akamai and served as the chief architect for the division.

Arvind received a Bachelor of Technology in Computer Science from Indian Institute of Technology, Delhi and a Master of Science in Computer Science from University of Washington. He has co-authored several web and networking standards and is a co-inventor of over 50 pending/approved patents.

## Soham Mazumdar / Co-founder and Architect

Soham was the co-founder and CTO at Tagtile, a mobile loyalty company, which was acquired by Facebook. Previously, he was an early engineering lead at Google, where he spent over 6 years working on search infrastructure and data mining. He was one of the founders of Teragoogle, a complete re-architecture of Google’s Search Infrastructure, for which he was awarded the Google Founder’s Award.
